### Welcome to Winchester City Council's latest Open Space Assessment.

We are lucky to live in a beautiful district and the green open spaces in our city, towns and villages play an important role in enhancing our lives and enabling local people to live active and healthy lifestyles.

Many of these open spaces are demonstrably special to local communities and often hold a particular local significance because of their beauty, their wildlife value, their historic significance, their recreational value or their tranquillity.

This document lists and maps all these important open areas across the district and includes not only the formal recreational sites like play areas, parks, recreation grounds and sports fields, but also green spaces with a significant amenity value which help define the character and appearance of an area. Many of these areas may be important for their environmental functions too, such as holding floodwater, countering air pollution or helping reduce urban temperatures in summer.

The council's open space standard seeks to ensure that where new development takes place, adequate and appropriate open space is provided to make sure that open space infrastructure keeps up with new housing provision.

However, urban open space is often under intense pressure in the light of rising demands from our busy, growing population. This Assessment therefore identifies those open spaces that will continue to receive protection in the Local Plan.

1. INTRODUCTION

This Open Space Assessment is a 'background paper' to the adopted Local Plan. It lists, maps and quantifies important open areas in and around the towns and villages of the district, where Winchester City Council is the local planning authority.

Villages and parishes within the South Downs National Park (SDNP) area are not included. Where parishes

straddle the boundary with the SDNP, only those parishes which have their main settlement or village outside of the SDNP are assessed, for example Bishop's Waltham, Wickham and Denmead. Parishes which straddle the boundary but have their main village or settlement inside the Park are to be assessed by the SDNP Authority using a similar format.

Some important open areas may not be publicly accessible, like private school

or college playing fields. These green spaces continue to benefit from protection in the Local Plan and have therefore been mapped but not added to the quantum of publicly accessible open space, unless the school or college allows access to the community, on some sort of managed basis.

Also included on the maps and in the schedules are open green areas with a significant visual amenity value. Most of these areas were previously identified under Policy RT1 in the earlier 'Local Plan Review' but have been reviewed and added to.

Areas with visual amenity may not necessarily be useable recreational open spaces but nevertheless

contribute substantially to the appearance and local distinctiveness of an area, and help define the character of the district's towns and villages. Some of these areas may also be important for their biodiversity or heritage value. The schedules in the assessment indicate in each case why the open area is protected. Many open spaces warrant protection for a number of reasons.

Open spaces selected for inclusion in the Assessment have been compiled with the assistance of each parish council. The previous list of important open spaces were sent to

the parish councils in June 2020 and most of the parishes responded with corrections, updates and additional open spaces for Winchester City Council to consider.

All of these important open spaces are now supported by Winchester City Council's geographical information systems (GIS) and are included on a mapping layer which will be kept up to date.

The purpose of the Assessment and the corresponding policies in the Local Plan is to provide some protection for these sites, which can be subject to development pressure, particularly within settlement boundaries.

The Assessment also identifies specific needs and shortfalls of open space and indicates what further open space provision may be needed in each area.

Understanding the need for open space in each area ensures that Winchester City Council remains compliant with the advice contained in the Government's latest 'National Planning Policy Framework'\* (February 2019) paragraphs 96 and 97:

96. Access to a network of high quality open spaces and opportunities for sport and physical activity is important for the health and well-being of communities. Planning policies should be based on robust and up-to-date assessments of the need for open space, sport and recreation facilities (including quantitative or qualitative deficits or surpluses) and opportunities for new provision. Information gained from the assessments should be used to determine what open space, sport and recreational provision is needed, which plans should then seek to accommodate.

97. Existing open space, sports and recreational buildings and land, including playing fields should not be built on unless:

 An assessment has been undertaken which has clearly shown the open space, buildings or land to be surplus to requirements; or

 The loss resulting from the proposed development would be replaced by equivalent or better provision in terms of quantity and quality in a suitable location; or

• The development is for alternative sports and recreational provision, the benefits of which clearly outweigh the loss of the current or former use.

Previous editions of this Assessment dealt only with children's play space, sports grounds and informal green space. These typologies were those set out in the earlier Local Plan Review's Open Space Standard and referred to in Policy RT4. These open space types and the standard applied at that time had been adapted from nationwide standards and advice contained in the National Playing Fields Association's '6 Acre Standard' document.\*\*

However, in response to the advice in the government's Planning Policy Guidance document PPG17 that open space standards should be 'locally derived', Winchester City Council commissioned

a district-wide 'Open Space Sports and Recreation Study' in 2008 which recommended an increase in the open space standard from 2.8 hectares per thousand people, to 4.0 hectares per thousand people and a wider range of open space typologies.

To accord with this change therefore, important open areas are now broken down into the following categories:

- 1. Allotments:
- 2. Informal Green Space
- 3. Natural Green Space
- 4. Play space
- **5.** Parks, Sports & Recreation Grounds

### ALLOTMENTS

Allotments: i.e., large or small areas used by communities for growing food;

#### INFORMAL GREEN SPACE


Informal Green Space: i.e., publicly accessible and useable open space which has not been allocated for any other use and is neither laid out nor managed for a specific function such as a play area, a park, a recreation or sports ground, a nature area or an allotment. These areas of open space will vary in size but are likely to have the following characteristics: open and unlikely to be physically demarcated by walls or fences; predominantly laid down to mown grass; unlikely to have identifiable entrance points (unlike parks); unlikely to have planted flower beds or other formal planted layouts, although there may be shrub and tree planting; generally no other recreational facilities and fixtures (such as play equipment or ball courts), although there may be items such as litter bins and benches. Examples might include both small and larger grassed areas in housing estates and general recreation spaces. The advantage of this type of open space is that it can serve a variety of functions. Some areas will be used for informal recreation activities like 'kick-about' or dog walking. Others can by themselves or collectively also contribute to the overall visual amenity and character of an area. Many informal green spaces perform an important urban cooling function and many act as sponges for flood water.

Natural Green Space should be viewed as important a component of community infrastructure in planning for new development as other forms of open space or built recreation facilities. Natural Green Space can make an important contribution toward Biodiversity Action Plan targets and can also raise awareness of biodiversity values and issues.

In those settlements in the district (outside the SDNP) where it is clear that there are still open space needs in the community (see overleaf) and this Assessment reveals there to be deficits in either quantity, quality or

accessibility, consideration will be given to releasing Winchester City Council held CIL funds, particularly for those larger facilities like Sports Grounds, Parks and Recreation Grounds, to 'top-up' those CIL funds received by parish councils from each CIL contribution.

However, in many existing urban areas, while it will be possible to ascertain notional shortfalls in open space and identify specific needs, it will not always be

feasible to overcome these shortfalls. While the Local Planning Authority will seek improvements in the open space network where it can, the most recent open space standard of 4.0 hectares per thousand population (significantly higher than it was in the previous Local Plan) is unlikely to be achieved in every

existing settlement or urban area and is instead more pertinent and attainable where new housing development is taking place. The council's strategy is therefore to protect and where possible enhance the existing urban open space network.

### 4. REVIEW AND MAIN FINDINGS

**OPEN SPACE ASSESSMENT** 

The Assessment has been reviewed in the light of population increases in the district, and the provision of new open spaces in conjunction with new housing, since the last edition of this Assessment was produced in 2015, to see whether open space infrastructure at the district scale is 'keeping pace' with the provision of new houses.

The population of the district (excluding the SDNP area) has grown since 2015 from 109,610 to 115,129 in 2020, i.e., almost a 5% increase. In the same period the availability of useable open space has also grown from 1,220 ha to 1,324 ha, i.e., an increase of almost 8%. But while the total district quantum of open space has grown there continue to be several wards and parishes with severe shortfalls of open space – see opposite.

The Local Plan open space standard of 40m<sup>2</sup> per person (4.0 ha per thousand population) has also been reviewed to see if it is still set at an appropriate level. There continues to be an even split between those parishes and wards in deficit and those in surplus which ndicates that the standard is still set about right. However the open space standard will continue OPEN to be reviewed in SPACE future assessments.

The following Parishes / Wards continue to have a surplus of accessible open space when assessed against the 4.0 ha standard in the Local Plan:

### 5. THE SCHEDULES & MAPS

**OPEN SPACE ASSESSMENT** 

#### The Schedules

Each parish or ward has a population total, which is taken from the latest Hampshire County Council 'Small Area Population Forecasts', which run until 2026. A population total allows a calculation to be made of how much open space would be required to meet the standard of 4.00 ha per thousand people. The amount of open space required in each area for each open space type is listed under 'CP7 Requirement'.

Each open space within the parish or ward is then grouped according to type and quantified with an indication of its reason for protection and whether it is publicly accessible or not. Open spaces may be useable recreational open spaces or important for their visual amenity or important due to their biodiversity or heritage assets.


The total amount of space in hectares in each group is then compared with the CP7 requirement to see whether there is a surplus or a deficit in each category, which is then listed under 'Adequacy'.

The 'Needs and Opportunities' section provides some commentary and analysis of the statistics above.

#### The Maps

Each open space site in each parish or ward is given a reference number and is shown on an individual map. The maps indicate, where relevant, each settlement boundary. Open space sites within the settlement boundary are protected by virtue of open space policies in the local plan (currently policy DM5 in local plan part 2) while open space sites outside of the settlement boundary, like village recreation grounds for example, receive protection under countryside policies.





This is a rural village with good access to open countryside. There is a play area but this needs further improvements to bring it up to LEAP standard. There is no play area in Gundleton. There are shortfalls in all categories of public open space and the privately owned Manor Farm Field is of a good size but is in poor condition with a sub-standard pavilion.

The town is surrounded by accessible countryside and has good sports facilities at Alrebury Park. There is nevertheless a shortfall of public open space in the town when assessed against the WCC Local Plan standard. It is intended that the proposed housing allocation to the east of Sun Lane will provide substantial areas of public open space in order to ensure open space deficiencies are not exacerbated as the town grows.


#### NEEDS & OPPORTUNITIES

The two most recent new housing site allocations are providing significant amounts of public open space. This includes sports pitches and a pavilion on land to the east of Mill Lane and at the Glebe Land, informal green space, parkland and equipped play space. Knowle is well supplied with accessible open space. There are however still shortfalls of allotments and equipped play space. Parks and Recreation Grounds are included under 'Sports Grounds'. Any future housing development in or around Wickham must factor-in sufficient quantities of open space to avoid further deficits.







#### NEEDS & OPPORTUNITIES

The St Barnabus Ward of Winchester now comprises the built-up areas of Teg Down, Weeke and Harestock. Taken in isolation as a suburb of Winchester, St Barnabus Ward is deficient in open space provision when assessed against the standard in the Local Plan. There are very few opportunities to add to the overall quantum of open space and the objective is to protect what there is from encroachment and concentrate instead on improving what exists in terms of quality and accessibility. 



#### NEEDS & OPPORTUNITIES

St Luke's Ward has shortfalls of open space. There are deficits in Natural Green Space, Equipped Children's Play Space and publically accessible Sports grounds. The shortfalls of open space are partly to be expected because this is a heavily built-up part of town with no easy access to open countryside. This is compensated to some degree by the presence of two good Parks at Somers Close and Cromwell Road and extensive areas of Informal Green Space at The Valley and the slopes between Stanmore and Badger Farm. The council will seek to retain, protect and improve these facilities which, as urban housing densities rise, become more valuable. There are opportunities as part of the Stanmore Planning Framework to provide improvements to the existing green spaces.





Despite containing Oram's Arbour, one of the City's best parks, there is a significant shortfall of publically accessible green space in St Paul's Ward and not particularly easy access to open countryside for walkers or cyclists. This is to be expected in a historic suburb and the opportunities to add to the quantum of accessible green space are inevitably limited. The sports grounds and playing fields in the Ward are not publically accessible but are mapped and protected. The Royal Winchester Golf Club occupies a large segment of the ward but is not included in the schedule as golf courses do not form part of this assessment. The objective is to retain, protect and improve open spaces in the Ward.



The Government says that 'access to a network of high quality open spaces and opportunities for sport well-being of communities'. (NPPF c 96). It therefore requires all planning authorities to maintain a 'robust space' in its area, which should show where there are

It is used to identify which existing open spaces should be protected from development.

The Government says 'existing open space, sports and recreational buildings and land including playing proposal, in order to avoid exacerbating shortfalls. fields should not be built on' (NPPF). All important open spaces within settlement boundaries identified in this assessment are designated in the Local Plan as protected open spaces (currently Policy DM5).

Information gained from this assessment allows the local planning authority to determine where open space is needed, which the Local Plan should then accommodate. For example, the last Open Space Assessment informed the preparation of the last Local Plan's housing allocation policies which specified for each needed and how much

open space should be provided within each housing

It is also used by house builders and developers in order for them to understand what open space they might need to provide in their plans.

NB: public open space provided by developers in this way was, in the past, frequently adopted by the council, however this is increasingly discouraged due to limited council resources. A revised procedure for transferring and adopting open space was agreed in March 2021 which now requires developers to arrange at planning stage alternative means of maintaining open space.
