With Reference to: Regulation 19 Local Plan consultation

Thank you for sharing the Local Plan Regulation 19 consultation with NHS Hampshire and Isle of Wight Integrated Care Board (ICB). Our comments below are provided based on how primary care (access to GP services) is both supported and impacted by the proposed Local Plan.

During the Local Plan process the ICB has been engaged with the proposed site allocations and assessed the existing primary care infrastructure capacity. The ICB have advised that the GP practices within the Winchester City Council area are already operating beyond their patient capacities. The current primary care infrastructure capacity can support a maximum of 112,898 patients, however the number of patients registered exceeds 131,000, therefore there is insufficient capacity to accommodate the proposed developments.

The ICB supports the Local Plan vision (Page 19) which highlights the need for ongoing enhancement and sustainability of local communities to address the needs of the area. Access to health care services has an important role to play in ensuring that this vision is met, and we note the commitment that physical and social infrastructure will need to be provided to reinforce and maintain a strong sense of community and identity.

The vision also states that for the market and rural towns to remain attractive settlements then there is a need to underpin the resilience of local services and facilities.

The corresponding Living Well objective (Page 21, ii) follows on from the vision stating that the plan will deliver inclusive communities with a range of services and infrastructure in sustainable neighbourhoods, including community infrastructure.

Access to sustainable and accessible GP services are not only important to the local population but also a vital facility that is used by the whole community and will be a key component to the Local Plan Vision and Objectives.



As per the communications and engagements throughout the Local Plan process between Winchester City Council and the ICB, the NHS will be seeking contributions ensuring that there is sufficient primary care capacity to meet the needs of the proposed site allocations.

This is supported by Strategic Policy SP2 (pages 23 and 24) which states:

In delivering the district's housing, employment and community requirements development proposals will be expected, where appropriate, to:

x. Undertake an assessment of the infrastructure and service capacity to serve new development and make arrangements in a timely manner for appropriate increases in infrastructure capacity or measures to mitigate impact.

Furthermore, **Strategic Policy D5** Masterplans (pages 99 and 100) also includes the following statements which supports the requirements for developers to mitigate the direct primary care impacts:

Any application for significant development on sites occupied by major landowners/users should be preceded by, and is expected to achieve the following objectives proportionate to the scale of the site and proposed development:

*x.* Provide for appropriate employment provision and community facilities to serve the new development (e.g. local shops, community halls, schools and **health** *facilities*)

The ICB acknowledges and supports the 'High Quality, Well-Designed Places and Living Well' chapter, specifically page 61 where it replicates the principles of the NNPF and section 5.8 which states that having access to services and facilities is a requirement of Living Well.

The ICB also supports the wider contexts within this chapter (page 67) which highlights the importance of planning for an ageing population and ensuring that your places are accessible to all and people living in our community have access to the services and facilities they need and opportunities to maintain their health and well-being and reduce social isolation.

The Local Plan continues this approach in the Local Shops, Facilities and Services chapter (page 293) where it stresses the vital role that health centres have in ensuring the vitality and viability of local communities.

Throughout the 'Development Allocations Winchester' chapters (page 306 onwards) the Plan includes the narrative highlighting the shortfalls in primary care capacity and the need for developers to liaise with the NHS to establish potential Section 106 contribution requests. Access to GP services is critical to the success of the objectives set out in the Local Plan, it is one of the few services that will be used by all occupants of new housing and their need is immediate. The ICB has reviewed the housing allocation policies and have commented as per Appendix A at the end of this response. The ICB has submitted draft Infrastructure Delivery Plans and is committed to keeping these up to date on a regular basis to ensure that developers will be informed as to the projects and funding that will be required to make their applications acceptable in planning terms.

NHS Hampshire and Isle of Wight ICB look forward to working collaboratively with Winchester City Council to deliver the Winchester City Local Plan, ensuring healthcare infrastructure meets the needs of Winchester residents.
