Self and Custom Build Housing

Position Statement January 2025

Introduction

The purpose of this note is to provide an update on the current position regarding the demand and supply of self and custom-built housing.

Demand

The Council has operated a register for those seeking a self build property since 2016. The demand recorded on the register has been reported to Government each year, who have then published these figures on their website¹.

The Council introduced a Local Connection Test during April 2019 (Base Period 4), that has applied to the register from that point onwards. From that date, individuals and associations who apply for entry on the Register and who meet all eligibility criteria must be entered into Part 1 of the Register. Those who meet all criteria except the local connection test are entered onto Part 2 of the Register.

The Local Connection Test was resolved at Cabinet (Housing) Committee on the 20 March 2019². The report noted that since the introduction of the Register in 2015, it *“only covers the areas of the Winchester District, that fall outside of the SDNP. However, this fact was not made clear during the application process, nor on the Self Build page of our website.”*

Around 40% of the District’s area, and 10% of the existing housing stock, falls within the South Downs National Park³. The national park covers, understandably, the more rural parts of the district and quite a large area, so it is to be expected that some entries prior to 2019 were made by those seeking a home in the distinctively different area in the National Park, rather than the district as a whole.

Further to this, a review of the register was conducted during early 2020, resulting in 116 entries being removed from base periods 1 to 4 of the register. This comprised

contacting registrants via phone call, email, and letter, over the course of a 4-month period – if after this time a response was not received, then the entry was removed from the register.

This approach and the number of people recorded on the self build register was confirmed to be appropriate in an appeal⁴ that was dismissed against the decision the Council made for a development at *Land between Nightingale Cottage and Whingarth, High Street, Shirrell Heath, SO32 2JH* where the Inspector concluded at paragraphs 28 and 29 that:

“The 2015 Act allows a relevant authority to remove an entry where, amongst other reasons, the person has ceased to be eligible to be entered on its register. No definition is provided of what would cause that cessation of eligibility. Guidance issued by the Right to Build task force states that the figures for base periods cannot be adjusted once a base period ends. However, the 2015 Act does allow for removal of entries without any restriction based on time.

Granting permission for a plot as self-build restricts its potential for development only to those who have primary input into its design and layout. It seems reasonable to me to ensure that the supply of such plots should meet demand, but not that a Council should be required to significantly exceed it. That a review was carried out to ensure that demand remained as registered therefore seems reasonable, and I note that the guidance issued by the task force on using register numbers to identify plots to be permissioned is dated March 2021. It is not therefore clear what guidance was available at the time the register was reviewed. While it would not be appropriate to make it more onerous to remain on the register, I note that in this instance the Council made multiple efforts to contact each person over an extended period before they were removed from the register, and therefore no onerous effort was required on the part of the registered people to remain on it. Furthermore, there is no indication that removal from the register precluded anyone from re-entering their name on it.”

It is envisaged that this review process would have resulted in the removal of the majority, if not all, of the entries relating to those who had registered with the Winchester City Council by mistake, rather than the South Downs National Park Authority.

2024 Self-Build Establishing Robustness Letter

During February 2024, the Council conducted another exercise to confirm the robustness of the register. A letter was sent to all those registered on the Self & Custom Housebuilding register to ascertain a true reflection of the robustness of the register and to ensure the Council can adequately plan for future development needs. The letter asked a series of questions of which would allow the Council to

update the information linked to those on the register, or where necessary, remove from the register where a responder requested to do so. In addition to this, the Council further stated that a future register review was also being considered.

The questions posed are set out below:

- Have your needs for a Self-Build or Custom Housebuilding plot been met for example, have you developed a Self-Build plot, or decided against the idea?
- Do you wish to remain on the Self-Build and Custom Housebuilding register?
- Confirmation of your full name, address, and telephone number
- Budget for development and funding source e.g., Mortgage in Principle, savings, inheritance (non-exhaustive)
- Are you on more than one Local Planning Authorities' Self-Build register, if so, are you on Part 1 or Part 2? If you are located in the South Downs National Park and you are seeking to develop a Self-Build or Custom Housebuild home in the National Park, it is important that you register your interest with the South Downs National Park Authority rather than with Winchester City Council.

The Council requested a response as soon as possible and stated that further contact would also be made of which a reminder was sent on the 29 February 2024. From the 407 entries to the register, the Council received 169 responses resulting in 45 entries that were removed from Part 1 of the register. This resulted in a reduction of 23 plots from the overall need and helped in establishing a truer reflection of the need for Self and Custom Housebuilding development. Where a respondent requested removal from the register that had applied during a previous base period, the entry was removed from the register but not the overall need; only entries that had been included on the register in current or later base periods were removed from the overall need⁵. It should be noted that entries were only removed from the register when asked to do so in response to the information request letter – this is in line with Regulation 10 (1) (a) of the Self-Build and Custom Housebuilding Regulations 2016. Any entry that was removed from the register does not preclude a removal to rejoin the register at a later date. In the event of a death or a duplicate entry⁶, these entries were also removed, with duplicate entries accounting for 18 removals and a reduction of 16 plots.

Since this exercise, during the year to 30 October 2024 (Base Period 9) a further 18 individuals (and one group seeking three plots) met the conditions for inclusion on Part 1 of the register, and 3 individuals were added to Part 2 of the register.

Finally, the way groups were treated in the register was reviewed. This resulted in two groups previously added to Part 1 of the register in base periods 1 and 3 being identified. Both of these groups are seeking two plots, and therefore these additional plots should be added to the assessment of demand.

Therefore as at 30 October 2024, the Council's self and custom build register records the following demand –

It has been noted that the records on the government website differ significantly from the current position, primarily due to the revisions following the identification of the issue regarding the national park. Therefore this note has been produced to explain the differences, and the Council is currently in discussions with MHCLG about revising its records and website to reflect the historic issues with the Winchester custom and self build register.

Supply

As at 30 October 2024, permissions have been granted for 240 self and custom built properties. The breakdown of permissions issued each year is as follows –
