Hope you had a nice weekend.

One of the officers came back to me today regarding two of the proposed changes, these are minor amendments which I hope you will be happy with, there is further explanations for them below which Adrian is also in agreement with.

- 1 Creating a vibrant economy (p261, para 10.9). EH suggest adding in 'heritage'. This is in the background text to the topic. The paragraph headed 'Culture, creative and visitor economy' reflects the wording in the GEDS, so I don't think we can alter this if that is not what is in the GEDS.

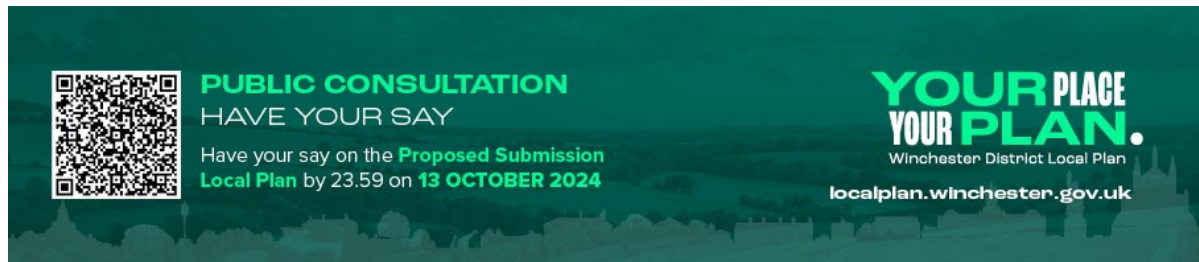
- 2 CC2 I think the convention is '**up to**'. I would prefer that to 'no more than' as it doesn't seem quite so restrictive. No more than might be too absolute when we consider all aspects of the proposal eg viability.

Could you let me know if you are happy with these wording tweaks by the end of the week, I know you are busy with lots of other Local Plans, so understand if you can't get back to us right away.
